#### IN A NUTSHELL

IIIEO-

- Publication Forum in Finnish Julkaisufoorurumi, or JUFO is a classification of publication channels created in 2010 by the Finnish scientific community to support the quality assessment of academic research (at marco-level).
- Purpose of Publication Forum classification is to identify peer-reviewed journals/series
  (journals, conferences book series) and book publishers (level 1), and to indicate those that
  have the widest respect and strongest impact in the research community


#### STEERING-GROUP

- Steering-group appointed by the TSV government for a 4-year term is responsible for appointing panels, the evaluation criteria, instructions and control
- Steering-group is broad-based:
  - Federation of Finnish Learned Societies
  - Universities Finland UNIFI
  - Ministry of Education and Culture
  - Academy of Finland
  - The National Library of Finland
  - The joint library network
  - CSC IT Centre for Science
  - 5-6 Experts from main fields of science
- Personnel at TSV include Publication Forum secretariat (2 persons full-time)



#### **EXPERT-PANELS**

- 23 panels appointed by the steering-group for a 4-year term have the responsibility for the classification of publications channels
- Suggestions from learned societies, science academies, universities and public research institutes
- ~250 experts from universities and public research institutes (8-13 per panel).





#### LEVEL CATEGORIES

- Level 1 = BASIC scientific publication channels
  - Publish mainly research results, scientific quality control (peer review), edited by scientific experts,
     main audience are other scientific experts
- Level 2 = LEADING scientific publication channels
  - Researchers from various countries publish their best research, but also most important channels in national languages
- Level 3 = TOP journals and series
  - Virtually all published research is highest level in its field, larger coverage of a research field, edited by leading researchers, publishing in these journals/series is highly valued in research community
- Level 0 = OTHER identified publication channels
  - Do not meet the criteria of scientific publication channel (level 1)
  - Local (more than one-half of authors represent the same organization)
  - Not considered relevant from the Finnish research perspective



#### **EVALUATION**

- Level 1 criteria (peer-review, editorial board, etc.) are typically checked from website
- Level 2 and 3 classifications are based on overall assessment relying on wide range of information, considering balance between different subfields and specialties

#### LEVEL QUOTAS

- The Expert Panels cannot classify all publication channels that are used and appreciated by the scientific community as levels 2 and 3, instead they have to make choices within the level quotas
- Level 3 journals may cover at most 5 %
- Level 2 journals may cover at most 15 %
- of the total publication volume of level 1-3 journals
- The quotas are calculated on the basis of the publishing volume, i.e. the annual number of publications published in the issues of the journal
- The purpose of the quotas is to balance out the classification between different fields of science

#### **PROCEDURES**

- Complementary Evaluation: new channels can be added continuously to level 1
  - New additions suggested on Publication Forum website and suggested upgrades from level 0 to level 1
  - New channels identified from the publication data universities report annually to VIRTA Publication
     Information Service
- Review of Ratings: level 2 and 3 classifications are updated every 4 years
  - Concerns all channels at levels 1, 2 or 3
- Corrections: between Reviews, individual changes to the level 2 and 3 ratings can be made only in case panel finds an important mistake in the classification.
- Suggestions: researchers can suggest new additions to level 1, as well as upgrades and downgrades to level 2 and 3 all the time in JUFO-portal or Publication Forum website



# WHY PUBLICATION FORUM?



#### **BACKGROUND**

- University funding by government in Finland has been partly based on performance since 1990s
- Publication count as funding criteria of Universities since 2007, insufficient attention to quality
- Finnish Council of University Rectors (UNIFI) working group to develop quality indicator 2010:
  - Citation analysis is well-established in natural sciences and medicine but sources cover poorly engineering, social sciences and humanities
  - Norway (2005) and Denmark (2009) developed a quality index of publications channels that cover the international and national output of universities in all languages and formats: journal articles, proceedings, book chapters and monographs
- Research community represented by the Federation of Finnish Learned Societies (TSV) was entrusted in 2010 with the task of developing the Publication Forum rating
- Funding from the Ministry of Education and Culture




#### **COVERAGE**

 International citation databases (Web of Science and Scopus) provide incomplete coverage of peer-reviewed outputs, especially in the social sciences and humanities




■ Share of Finnish articles included in Scopus





#### **PUBLICATION TYPES**


 Fields differs considerably in use of English and other languages in publishing peer-reviewed research results





#### **PUBLICATION LANGUAGES**


 Fields differs considerably in use of journal articles, conference articles and books in publishing peer-reviewed research results





#### **SSH SPECIFISITY**


- Practically the same share of journal articles published in English, Finnish and Swedish count
  in the PRFS as level 2 and 3 publications
- English language book publications have a more advantageous distribution





#### SCIENTIFIC IMPACT

- Publication Forum level ratings correlate with citation impact
- Finnish Web of Science –indexed output from 2011-2015 in level 3 journals has on the whole – more citations than output in level 2 journals, or in level 1 journals





# HOW TO USE PUBLICATION FORUM?



#### **MACRO-LEVEL**

- In the OKM funding model, the review focuses on the more than 25,000 peer-reviewed publications produced annually.
- A publication-specific expert evaluation of these would constitute an unreasonable amount of work. Therefore, the expert evaluation in the JUFO process focus on publication channels, not on individual publications.
- The publication indicator of the funding model and the related JUFO classification implement the following principles of responsible research metrics:
  - Robustness: basing metrics on the best possible data in terms of accuracy and scope
  - Transparency: those being evaluated can test and verify the results
  - Diversity: accounting for variation by field, and using a range of indicators
  - Reflectivity: recognising and anticipating the effects of indicators, and updating them in response



#### **FUNDING-MODEL**

- Since 2015, 13 % of public funding of universities from the Ministry of Education and Culture is based on publications
- Publications are weighted based on the publication type and JUFO-level of the publication channel
- Extra-weight of 20 % will be introduced in 2020 for openly available publications

#### UNIT AND INDIVIDUAL LEVEL

- According to the recommendations of the Leiden Manifesto for research metrics and the Metric Tide report, the evaluation of the quality of research must primarily be based on expert evaluation, but research metrics can be used to support the evaluation.
- According to Publication Forum User Guide, anyone who uses JUFO-classification to support expert evaluation need to consider the following:
  - limitations concerning the use of the Publication Forum classification system;
  - also use other publication channel and/or publication-specific research metrics as diversely as possible and consider the differences and characteristics of various fields of science;
  - use the expertise of libraries and/or other bibliometric experts in the creation and interpretation of research metrics based on the Publication Forum classification;
  - explain to the personnel in a transparent way in which contexts and how the Publication Forum classification is used;
  - hear researchers' views about the applicability of the Publication Forum classification for various evaluation purposes in their own field of science or research.


